OLD BUSINEES:

1. Buzzell Rd. Ted Poirier is concerned about the condition of the asphalt from the work that was completed on Buzzell Rd. Paul Poirier, who completed the work on Buzzell Rd has offered to try to fix up the road. Ed Littlefield and John Hall, Littlefield & Hall Excavation, feel that the work was not completed according to bid specifications. Scott Hebert, Dearborn Construction, suggested that with the high temperatures that trying to fix the road now may damage the road even more. Paul Poirier to come up with a plan of action to address the issues on the Buzzell Rd.
