**OLD BUSINEES:**

1. Solar Update. No update at this time.
2. RSU 23. Scott Littlefield communicated that at the last RSU meeting that Theresa Greeley and he attended the town's letter to the RSU regarding the cost sharing plan was discussed and voted on. There is some confusion on when the RSU might start to review the cost sharing plan. Angela Cushman to follow up with Barry Hobbins and Gary Connors regarding the list of items the Town sent to them regarding the RSU.

**NEW BUSINESS:**

1. Michelle Boisjoly, Tax Assessor – mil rate. Michelle is suggesting that the mil rate be set at \$16.05 with an overlay of \$43,581.92. This mil rate is a \$1.50 more than next year. Some discussion was held regarding having multiple tax bills. Angela Cushman communicated that to make a change from one bill to multiple bills a vote would need to occur at the annual town meeting. Angela Cushman to complete some analysis on cash flow. The Selectmen agreed with the \$16.05 mil rate.
2. Treasurer reporting. Angela Cushman reviewed year to date revenues and expenses with the Selectmen.
3. Tax Collector reporting. Yvonne Shaw provided a monthly update to the Selectmen. For the month of July the Town received approximately \$27,000 in motor vehicle excise and \$550 in boat excise.
4. Fire Commission letter. The Selectmen reviewed a letter received from the Fire Commission requesting the Selectmen to provide a specific of items to the Fire

- Commission by September 30<sup>th</sup> and to meet with the Fire Commission on October 5<sup>th</sup>.
5. Next Selectmen's meeting. Next meeting will be on August 30<sup>th</sup>.
  6. Road Commissioner. Mike Souliere communicated that he is currently obtaining pricing for a culvert on the Dennett Rd.

**PUBLIC FORUM:**

John Gay expressed his concerns on the Union Falls Rd culvert project. Where does the money come from? The road budget is on hold until the pricing is determined on this culvert project.
