

SELECTMEN MEETING MINUTES

June 1, 2020

ADMINISTRATIVE:

*Selectman Scott Littlefield declared the meeting open at 6:00 PM.
Selectmen approved agenda.*

APPOINTMENTS: N/A

OLD BUSINESS:

1. Fire Department Budget. \$10K was added to the workers compensation line.
2. Town Budget.
 - a. Education – no changes
Public Safety – Dayton’s portion of the \$10K results in at \$2,820 increase on the town budget.
 - Benefits – Some discussion was held regarding the benefits for the firefighters and town employees. No decision was made at this time. The Selectmen asked the Budget Committee to meet and develop a recommendation for the town employee salary line and health insurance line.
 - b. Public Works - \$1,000 increase to the snowplow contract in the event that Apple Blossom Lane is accepted as a town way.
 - c. Waste Management – no changes
 - d. General Government - \$2,381 decrease to County Taxes
 - Assessor Contract – the assessor submitted a new contract for the Selectmen to consider for 2020-2021. Alex Konczal is requesting to be paid on monthly basis instead of a daily basis with an increase to the daily rate. This item will be discussed again at the next Selectmen meeting.
3. Revenues
 - FD Surplus \$200,000 Dayton portion would be 28.2% is \$56,400
 - PW LRAP 25% reduction from last year’s actual
 - State Revenue Share 25% reduction from last year’s actual
 - Homestead Exemption – should we calculate a 28.5% reduction will be discussed with the Assessor.

4. Selectmen Meeting

- Deputy registrar of voters – the Selectmen approved having one of the ballot clerks to work some hours prior to election to help with processing absentee ballots.
- Request for time off


A Selectmen and Budget Committee will be held next Monday, June 8th at 6pm to finalize the town budget.
